Recently, National Grid performed an energy audit and recommended some ways we could reduce our energy consumption and save some money. This past week, we replaced several light bulbs with more energy efficient ones and also put water-saving devices on the kitchen faucets.

As part of the incentive for the program, National Grid paid for over 70% of the cost of these updates. The total cost was \$5202, of which we paid only \$1290. Our increased efficiency will help the environment and our budget!
